All applicants must be currently enrolled in a post-secondary school or technical training program. Applicants may or may not have previously received scholarship awards from the Foundation. To be eligible, applicants must:

- have successfully completed at least one year towards a bachelor or associates degree at an accredited institution of higher learning or a technical program.
- have a cumulative college level GPA of 3.0 or higher (on a scale of 4.0)
- complete the following application and submit the required 300 word minimum essay
- submit one copy of their college or tech school transcript
- submit a signed photo release form (last page of this application)
