

Chamber Affiliate Application

The Grove City Foundation awards both merit and need based scholarships to current employees of Chamber member organizations, to current individual Chamber members (who are not direct chamber employees), and to immediate family members of such member organization employees and individual members.

The nature of the affiliated relationship determines the application requirements and the program levels that are supported, such as seeking an Associates or a bachelor's degree, completing a certification program at an accredited degree- granting educational institution or receiving other technical training. Post baccalaureate (Graduate School) education scholarships are only available to persons who are current employees of a Chamber member - organization or are themselves individual Chamber members.

___You completed your secondary school education prior to the current calendar year and you are a direct employee of a Chamber's business member's company or you are an individual member of the Grove City Area Chamber of Commerce and you wish to acquire or complete post-secondary school education (including post baccalaureate degrees), pursue continuing education credits, technical training, or certification from an organization other than an accredited degree granting educational institution. If you check this box, follow the instructions for an "Affiliated Employee application"

B) Instructions for an "Affiliated Renew Application" Complete numbered sections 1-11, 14-17 and photo release

C) Instructions for an "Affiliated Employee Application" Complete numbered sections 1-12, 14, 17 and photo release

Applications for this category are evaluated and scholarships are awarded on a quarterly basis.

Application deadlines in 2024 are March 15th, June 14th, September 13th, and December 13th 2024. Applicants who are not awarded a scholarship in the quarter in which their applications are submitted must submit another application to be considered in a subsequent quarter. *Only one scholarship will be awarded to any individual's during a calendar year.*

Applications filed by mail or hand delivered to the Foundation office will not be considered.

Only one Application may be filed, and no more than one scholarship can be awarded to an individual, within a calendar year.
